Presentation of the KAP project

Many young people at the time of difficulties encountered in family or even in cases of major crisis find themselves with no shelter , with all the risks which are involved by such a situation and the difficulties to find a roof, even temporarily.

The CEMO, in partnership with two real estate agencies, provides places and put them at the disposal of its public. Several apartments of transit completely equipped.

Our project consists in being able to offer a place of autonomous and provisional accommodation. It is a question of creating the requirements with an educational and psychosocial accompaniment in order to allow a bearing total work on the resolution of the situation and support the future prospects (family status, schooling, autonomy, etc.)

The duration of accommodation is variable and will be defined according to the project of each recipient (three months to one year). The KAP is also declined on several places having their own specificities.

Targeted public

Our apartments of transit are in priority intended for young people aged from 16 to 18 years (with possibility of prolongation if dealt with before 18 years old)

- Without a stable situation
- Living in street or assimilated accommodation.
- In rupture and/or crisis with the usual environment of life.

We also give the possibility of hosting to people with whom an accompaniment by our service remains adequate. It is about:

- Minor relative with child
- A relative (18-25 years) with child
- A young person of less than 25 years

However the public is, the following criteria are necessary:

- to be without stable accommodation
- to be living in street or comparable
- to be in rupture with the usual environment of life
- In order of statute of residence for one period at least equal to the maximum duration of accommodation or hosting.

Our project KAP is firstly booked to the young people having one << inking>> with Saint-gills (schooling, social network). Our project implements a work of accompaniment at the acquisition of autonomy and is not a solution of accommodation or establishment. Accommodations (hosting) are associated to an accompaniment.

Modalities of admission

Having access to one of our apartments of transit is necessarily related to accompaniment and also to the respect of the fixed framework.

Request and motivation of the recipient for the project and adhesion with the psychosocial accompaniment :

- To respect the three dates of entry (as far as possible, including one with the person in charge of the minor).
- To commit itself respecting the contract of collaboration.
- To be in an aiming of evolution, of change.
- Authorization of the legal person in charge for the minors.

Financial aspect

The monthly financial expenses in our accommodation KAP are fixed at 470€. It approaches thus a rent in the private rental market.

This rental load contains an amount for the rent, an amount of provisions of load and possibly an amount for monthly savings.

These amounts thus vary according to the type of housing: small units having a rent and loads less low allowing the savings.

Duration of accommodation

Our project of accompaniment to autonomy was built over one duration of accommodation of maximum one year. It is concluded for a first renewable period of three months renewed three times maximum.

Each period is evaluated and the prolongation will be according to the adequacy of the project, the respect of the fixed working frame and the contract of collaboration.

Procedure: three key moments

The request

It requires a time of meeting and reflection which will proceed with through three talking moments extended over two weeks. This period of time will make it possible to the recipient to be confronted with the project and will allow us to analyze the adequacy of the request.

The stay and accompaniment

The personal project of the recipient will be always taken into consideration during all the period of the accompaniment. The young man or woman will be accompanied in an intensive way by two workers of the CEMO. The meetings are weekly. Workshops sets of themes are also programmed. The adequacy of the accompaniment with the KAP is regularly evaluated with the young person and the partners of the network.

Preparation at the exit

Whatever is the choice of a future project; we will support it in the approaches in order to be able to make the relay.

Some restrictions

So as to respect our working frame we cannot accept all the types of public.

Requests concerning situations of serious and recurring danger for which a placement is recommended will not be accepted.

In the same way, of important behavioral problems, the presence of a heavy psychopathology or problems of addiction will be incompatible with the project KAP.

The non-collaboration of the young person in the process of accompaniment is also an obstacle to integrate our project.
