#### **Presentation of the project KAP**

Many youths, as they encounter difficulties into the familial circle, find themselves "in the street" whit all the risks asso- ciated to such a situation and the difficulties to find a place to live, even a temporary one.

The CEMO<sup>1</sup>, in partnership with several Social Real-Estate Agencies (AIS in French), offers to its public some fully equip- ped temporary apartments.

Our project aims, through temporary and autonomous housing, to create the necessary conditions to an educatio- nal and intensive socio-psychological support. The goal is to offer a comprehensive work focusing on the acquisition of competencies and problems solving skills but also supporting the future prospects (regarding family situation, education, functional self-sufficiency, ...).

The duration of the housing is variable and depends of the project of each beneficiary (from 3 months to a year). The KAP is present in different areas in the city, each place ha- ving its specificities<sup>2</sup>.

## **Target Audience**

Our transit apartments are in priority destined to:

 Youth aged form 16 to 18 (with possibilities of prolongation if the youth is taken into the project before his majority) without a stable housing situation, living in the street or similar and in crisis/rupture with his usual living space.

We also have the possibility to host other persons with whom guidance from our service appears adequate. They are:

- Minor parent with child;
- A parent (18-25yo) with child;
- A youth under 25.

Regardless of the public some conditions are mandatory:

- No stable accommodation;
- Living in the street or similar;
- In rupture and/or crisis with the usual living place;
- In order of residency status for a minimum period of one year.

Our KAP project prioritizes young having a "local inking" in Saint-Gilles (education, social network). Our project exe- cutes a work of support to the acquisition of self-sufficiency and is not a housing solution. Nevertheless, the housing is intertwined with the guidance

## **Admission process**

The housing into one of our transit apartment necessarily comes along with a follow-up from our staff and by adhe- ring to the framework:

- Demand and motivation from the beneficiary for the project and adhesion to the psychosocial accompaniment;
- To respect the 3 entering interviews (in the set of capacities, one of them with a legal representative if minor);
- To enroll to respect the collaboration contract;
- Authorization of the legal representative if minor of age.

## **Financial aspects**

The monthly rent of our KAP accommodations is set up to 500€. This way, it is not too far from a usual rent. This lease payment covers the rent, the rental costs and eventually a monthly saving. Those amounts vary according the type of accommodation: the small units having less high rent and rental costs allow savings.

## The duration of the housing

Our project of guidance to self-sufficiency is build around a duration of housing of a year maximum. It is settled, at first, for a 3 months trial-period renewable 3 times maximum. Every period is evaluated and the extension will occur according to the project and in condition of the respect of the global framework and of the collaboration contract.

## The procedure: 3 key moments

#### The application

As this process requests time to meet but also to think about, it takes place through 3 meetings spread over several weeks. This time enables the applicant to embrace the project and allows the team to analyze the adequacy of the request.

#### The stay and the support

The heart of the support will always be the personal project of the beneficiary. Two workers of the CEMO will intensively accompany him/her weekly. Thematic workshops are also offered. The adequacy of the support is regularly evaluated, with the youth and with the network partners.

#### Preparing the exit

We support the youth's procedures towards his future projects.

## **Some restrictions**

Our frame of work doesn't allow us to accompany everyone:

- The youth's unwillingness for guidance is an impediment to enter the project.
- Requests concerning situations of grave and recurring danger necessitating a placement are not taken in charge.
- Requests concerning situations including important behavioral disorders, heavy mental issues or addiction problems are incompatibles with the KAP project.


